D. Discussion of Streetscape Phase III Design Options

Lou Fleury, OHM Advisors, discussed alternative options for reducing the scope of Streetscape Phase III with the DDA Board. Fleury states that one option could be to separate the West and East sections of the streetscape into two phases. Fleury then states another option would be to reduce the landscaping, reduce the paving thickness to 2", and to scale back the fencing and go with the original concept. Nelson states she is not opposed to the alternative fencing concept because it is labor intensive to replace the brick should anything happen to it. Fleury states that both the proposed fence and the alternative fence could be used, having different variations of both. Nelson suggests to cut a few things back and rebid in November. The DDA Board also discussed the option of only adding lighting at this time to the East side of the Streetscape while keeping the West side as proposed for a cost savings. The DDA Board decided to finalize their decisions at the September meeting in order to bid the project out in November.
