VI. APPLICANT SIGNATURE

VIII. FEE CLARIFICATIONS

Item # 2, RESIDENTIAL HEATING SYSTEM- This item is used for installation of a heating system in a new residential structure.
Items #10 GAS PIPING and #18 DUCT- Should not be charged.
NOTE: REPLACEMENT SYSTEMS SHOULD BE ITEMIZED.
Item #34 ADDITIONAL INSPECTION- Per Resolution #05-072 on 10-24-05.

IX. PLAN REVIEW REQUIREMENTS

Plans **are not** required for the following:

1. One- or two-family dwellings containing not more than 3,500 square feet of building area.
2. Alterations and repair work determined by the mechanical official be of a minor nature.
3. Business, Mercantile and Storage buildings have HVAC equipment only, with one fire area and not more than 3,5000 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00. If work is being performed as described above, answer Section IV "Not Required"

Plans **are** required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act. No. 299 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal.

PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.

X. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Mechanical work shall not be started until the application for permit has been filed with the Village of Birch Run. All installations shall be in conformance with the Village of Birch Run Mechanical Code. No work shall be concealed until it has been inspected.

WHEN READY FOR AN INSPECTION, call the Birch Run Village office at (989) 624-5711 providing as much advance notice as possible. The Village will need the location and permit number. The inspector has forty-eight (48) hours from the date and time of the call to complete requested inspection.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced, suspended or abandoned within six months after issuance of the permit.

A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF ISSUANCE OF THE DATE OF ISSUANCE OR THE DATE OF PREVIOUS INSPECTION.

CANCELLED PERMITS CANNOT BE REINSTATED AND SHALL BE VOIDED.
